RESPONSE REQUESTED: The following information could have a significant impact financially and operationally on all of Maryland's Fire Service.

- -OSHA is proposing a new rule to protect emergency responders, called Emergency Response. OSHA's current Fire Brigades standard, 29 CFR 1910.156, provides protection specifically to industrial or private firefighters but no other types of emergency responders. It was published in 1980 and has not been updated with subsequent improvements in personal protective clothing and equipment or advances in safety and health practices. OSHA proposes to replace the existing 29 CFR 1910.156 with the new Emergency Response standard. The new rule would provide updated health and safety protections for firefighters, emergency medical service providers, and technical search and rescuers. **See attachments.**
- -Federal OSHA does not have jurisdiction over state and local government workers. Maryland is a State Plan state that operates under the authority of OSHA with the requirement that it is "at least as effective", which requires State Plans to adopt OSHA final rules. All State Plans, including Maryland, must also cover state and local workers. A list of those states can be found here: https://oshspa.org/.
- -The Maryland Fire Service in partnership with the Division of Labor & Industry/MOSH is currently reviewing the proposed rule and is working to consolidate feedback to OSHA.

- -This SAFER-funded two-day workshop takes a retention-first approach to help participants evaluate the type of environment they're inviting potential members into and offers keen insight and process improvement from the moment of inquiry, to application and acceptance, and through the onboarding phase.
- -This immersive learning experience offers real-world experiences and solutions from leaders and subject matter experts working in your field. It shares processes and best practices that can increase your success at generating prospective volunteer interest, identifying and screening quality candidates; closing the deal on your next recruit committing themselves to serving in your Fire/EMS organization, and keeping them supported and engaged once you've got them hooked. This interactive encounter will identify and help address barriers to recruitment and retention in your volunteer agency.

DOI Launches Pilot Program to Strengthen Local Governments' Wildfire Response Capabilities

- -On Feb. 6, the Department of the Interior (DOI) <u>announced the launch of a pilot program</u> to strengthen local governments' wildfire response capabilities by converting vehicles to wildland fire engines.
- -The pilot program can be used by local governments to purchase slip-on tanker units that will allow them to quickly convert trucks and other vehicles to be operated as wildland fire engines. Local governments that provide emergency services to areas with a population of 25,000 or less are eligible to apply for this funding. Grant amounts will range from \$10,000 to \$200,000. The Bipartisan Infrastructure Law authorized \$50 million for the pilot program, and \$5 million is available during this first round.
- -The funding will help small, remote emergency response agencies quickly expand their wildfire response capacity. Grant applications must be submitted through the <u>Grants.gov website</u>. Statements of interest are due by **Thursday, March 21, 2024**. If invited, application packages will be due on **Tuesday, June 4, 2024**. Additional details about the pilot program and application process will be available in the Federal Register in the coming days.

<u>Call to Action: Please Help Reauthorize the Fire Grant Program</u> Earlier this week, representatives of America's fire service met on-line to discuss strategies to force Congress and the Senate to pass the reauthorization bill for AFG/SAFER/FP&S and the USFA. We have decided that the time is **NOW** to ask the fire service to unite and fill up the inboxes of Congress/Senate to address this critical issue.
